



NSBA Riders Cup General Information



The Riders Cup is designed to award purses to the NSBA Non Pro members and their professional trainers. All Riders Cup classes have a payout with a total estimated purse of \$80,000. NSBA's Riders Cup will be hosted at West World as part of the Sun Circuit on March 3-4, 2020.

With classes ranging from Trail, Western Riding, Hunter Under Saddle, Western Pleasure, Equitation, Horsemanship and Showmanship, there is a class and payout for everyone.

The Riders Cup purse is funded by trainers who donate one month's training. Trainers who donate one month's training and are sold through the NSBA Trainer Sale are eligible for participation in the Riders Cup. Trainers that have not sold one month's training through the Trainers Sale may pay a \$500 fee to become eligible to participate. Owners/Non Pro exhibitors must declare their entry under the name of a sold trainer.

Owners and exhibitors are required to be current members of NSBA. All horses must be registered with NSBA in the current owners name. Pre entries are accepted or can be made at the show.

The Riders Cup purse is generated from the Trainer Sale, owner nominations and 55% of all paid entries. Distribution of the purse follows NSBA payback and each class will be split 80% to the owner and 20% to the trainer.
