1/2 point

- starting a circle or setting a roll-back at a trot for up to 2 strides
- delayed change of lead by 1 stride where the lead change is required by the pattern description
- failure to remain a minimum of 20 feet from the wall or fence when approaching a stop or/and roll-back
- over-spin or under-spin 1/8 to 1/4 turn

1 point

- over/under (per measure)
- out of frame (per measure)
- out of lead in the circles, figure eights or around the end of the arena (cumulative, 1 point for each 1/4 of the circumference of a circle or any part thereof)
- over or under spinning 1/8 to 1/4 turn
- stopping rest

Penalty

- jogging beyond 2 strides, but less than 1/2 circle or 1/2 the length of the arena
- break of gait
- freeze up in spins or roll-backs
- failure to stop or walk before executing a lead
- deviation on 10-11 patterns
- on curve patterns, failure to be in a loop prior to the 1st marker
- if a horse does not completely pass the specified marker before initiating a stop position

Penalty

- spurring in front of cloth
- blatant disobedience (kick, bite, buck, rear, etc.) to each referrer
- use of either hand to assist backstrap

Off Pattern (OP) - to be placed below horses performing at minimum:

- breaking pattern
- violation of measure (e.g. over or under spinning, backing more than 2 strides, etc.)
- bobbing in excess of 1/2 circle or 1/2 length of the arena
- repeated blatant disobedience
- use of two hands (except junior and L1 horses shown in a snaffle with a shank)
- more than one finger between split reins or any fingers between normal reins (except in the two rein)

Disqualified - 0 Score

- lameness
- disrespect or misconduct
- illegal equipment
- wild shins
- leaving walking area before pattern is complete
- improper western attire
- fed of horse/ride


MANEUVER SCHEMATIC

1/2 circle

- starting a circle or exiting a rollback at a trot for up to 3 strides
- delayed change of lead by 1 stride where the lead change is required by the pattern description
- failure to remain a minimum of 20 feet from the wall or fence when approaching a stop and/or rollback
- over-split or under-split (up to 1/8 foot)

1 Lead

- over-bridged (per maneuver)
- out of frame (per maneuver)
- out of lead in the circles, figure eights or around the end of the arena (cumulative, 1 point for each 1/4 of the circumference of a circle or any part thereof)
- over or under spinning 1/8 to 1/4 turn
- slipping roll

2 Leads

- logging beyond 2 strides, but less than 1/2 circle or 1/2 the length of the arena
- break of gait
- knees up in spins or rollbacks
- failure to stop or walk before executing a loop
- departure on trot-in patterns
- on cut-in patterns, failure to be in a knee-up to the first marker
- if a horse does not completely pass the specified marker before initiating a stop position

3 Leads

- spurring in front of stride
- blatant disobedience (kick, kick back, rear, etc.) for each refusal
- use of either hand to hold headstall

Off Pattern (OP) - to be placed below horses performing all maneuvers

- breaking pattern
- inclusion of maneuver (e.g. over or under spinning, backing more than 2 strides, etc.)
- logging in excess of 1/2 circle or 1/2 length of the arena
- repeated blatant disobedience
- use of bad form (except jointed and L1 horses shown in a crafty address manner) more than one finger between split reins or any fingers between round reins (except in the low rein)

Disqualified - 3 Leads

- lameness
- disrespect or misconduct
- illegal equipment
- unsafe attire
- leaving working area before pattern is complete
- improper weight attire
- bid of horseholder

MANEUVER SCORES

Each maneuver is judged on a scale of 0-100 points, and automatically stops the run with a score of 70 points
 1-100 (excellent) 90-100 (good) 80-90 (fair) 70-80 (poor) 60-70 (fair) 50-60 (poor) 40-50 (poor) 30-40 (poor) 20-30 (poor) 10-20 (poor) 0 (poor)

1/2 circle

- starting a circle or exiting a roll-back at a trot for up to 2 strides
- delayed change of lead by 1 stride where the lead change is required by the pattern description
- failure to remain a minimum of 20 feet from the west or fence when approaching a stop and/or roll-back
- over-spin or under-spin up to 1/8 turn

1 lead

- over-circled (per maneuver)
- use of frame (per maneuver)
- out of lead in the circles, figure eights or around the end of the arena (penalizable: 1 point for each 1/4 of the circumference of a circle or any part thereof)
- over or under spinning 1/8 to 1/4 turn
- slipping rein

2 points

- juggling beyond 2 strides, but less than 1/2 circle or 1/2 the length of the arena
- break of gait
- freeze up in spins or roll-backs
- failure to stop or walk before executing a stop departure on 1/4-1/2 patterns
- on cut-in patterns, failure to be in a lead prior to the first marker
- if a horse does not completely pass the specified marker before initiating a stop position

3 points

- spurring in front of snout
- instant disobedience (kick, bite, buck, rear, etc.) for each refusal
- use of other hand to inflat footpress

Off Pattern (OE) - to be placed below horses performing off maneuvers

- breaking pattern
- violation of maneuver (e.g. over or under-spinning, tracking more than 2 strides, etc.)
- leading in excess of 1/2 circle or 1/2 length of the arena
- loaded instant disobedience
- use of two hands (except junior and L1 horses - grown in a snaffle with 2 hands)
- more than one finger between split reins or any fingers between reins (except in the two rein)

Disqualified - 0 Score

- lameness
- disrobed or misconduct
- illegal equipment
- self-eject
- leaving working area before pattern is complete
- improper western attire
- hit of horse/ider

1/2 mile

- starting a circle or setting a roll-back at a trot for up to 3 strides
- delayed change of lead by 1 stride where the lead change is required by the pattern description
- failure to remain a minimum of 20 feet from the west or fence when approaching a stop or/and roll-back
- over-spin or under-spin up to 1/8 turn

1 point

- over-bridged (per maneuver)
- out of place (per maneuver)
- out of lead in the circles, figure eights or around the end of the arena (cumulative: 1 point for each 1/4 of the circumference of a circle or any part thereof)
- over or under spurring 1/8 to 1/4 turn
- spurring out

2 points

- jogging beyond 2 strides, but less than 1/2 circle or 1/2 the length of the arena
- break of gait
- heels up in spins or roll-backs
- failure to stop or walk before executing a stop departure on bob-in patterns
- on run-in patterns, failure to be in a square prior to the first circle
- if a horse does not completely pass the specified marker before initiating a stop position

3 points

- spurring in front of cloth
- blatant disobedience (kick, back, rear, etc.) for each refusal
- use of other hand to hold leadrope

Off Pattern (OP) - to be placed below horses performing all maneuvers.

- breaking pattern
- execution of maneuver (e.g. over or under-spurring, backing more than 2 strides, etc.)
- trotting in excess of 1/2 circle or 1/2 length of the arena
- repeated blatant disobedience
- use of two hands (except junior and L1 horses shown in a snaffle with a maximum of more than one finger between split reins or any fingers between usual reins (except in the two reins))

Disqualified - 0 Score

- lameness
- disrespect or misconduct
- illegal equipment
- wild shins
- leaving walking area before pattern is complete
- improper western attire
- bit of harassment
