### Errors

- low gait (per gait)
- over-trotted (per maneuver)
- out of frame (per maneuver)
- break of gait at walk or trot for 2 strides or less
- wrong lead or out of lead for 2 strides or less

### Errors

- break of gait at walk or trot for more than 2 strides
- break of gait at lope, except when correcting an incorrect lead
- wrong lead or out of lead for more than 2 strides
- dropped reins (per maneuver)
- out of lead or cross-cantering more than 2 strides when changing leads
- cutting more than 2 strides when making a simple lead change
- trotting more than 2 strides in lope departures or when exiting a rollback
- severe disturbance of any obstacle

### Errors

- distinct disobedience (kick, bite, back, rear, etc.) for each refusal

### Off Pattern (OP) - to be placed below horses performing all maneuvers

- omissions or extra maneuvers
- incomplete maneuver
- repeated distinct disobedience
- Use of two hands (except junior and L1 horses shown in a crafty performance), more than one finger between split reins or any fingers between normal reins (except in the two rein)

### Disqualified - 0 Score

- illegal equipment including hoof block, braided or banded manes, or tail extensions
- intoxicated
- disrespect or misconduct
- willful abuse
- leaving marking area before pattern is complete
- improper position while
- fall of horse/ride

**1 point**

- too slow (per gait)
- over-bucked (per maneuver)
- out of frame (per maneuver)
- break of gait at walk or trot for 2 strides or less
- wrong lead or out of lead for 2 strides or less

**2 points**

- break of gait at walk or trot for more than 2 strides
- break of gait at lope, except when correcting an incorrect lead
- wrong lead or out of lead for more than 2 strides
- striped reins (per maneuver)
- out of lead or cross-centering more than 2 strides when changing leads
- cutting more than 2 strides when making a simple lead change
- cutting more than 2 strides in lope departures or when exiting a milking
- prove disturbances of any obstacle

**3 points**

- blatant disobedience (H/A, H/A, H/A, etc.) for each refusal

**Off Pattern (OP) - to be placed below horses performing all maneuvers:**

- eliminates or adds maneuver
- incomplete maneuver
- repeated instant disobedience
- use of two hands (except junior and L1 horses shown in a snaffle (bitless/amine), more than one finger between snail reins or any fingers between normal reins (except in the two rein)

**Disqualified - 0 Score**

- illegal equipment including hoof block, braided or braided wires, or tail extensions
- lameness
- disrespect or misconduct
- unsafe horse
- leaving working area before pattern is complete
- improper western attire
- fall of horse/rider
